Notes and Conditions

Students receiving any of these bursaries will be responsible for the remaining tuition fees, and other non-tuition fees as required. Anyone who is currently a Canadian citizen or has obtained Permanent resident status in Canada is eligible to apply for these bursaries. Application to any of these bursaries must be received in full (including all letters and the application form) three weeks prior to the start of the BBA program for consideration. A minimum GPA of 2.5 is required to receive any of these bursaries. Failure to maintain a satisfactory GPA will lead to the bursary being discontinued for the student. Special cases should be presented by letter to the student’s program advisor. Student’s who receive the Working Adult’s tuition bursary will have the value of the award and issue date recorded in their permanent student file. Should a student need to defer their start date, the value of the award will remain the same and take effect on the deferred start date.

The on-campus bursary for the Toronto campus covers 35% of tuition costs for courses taken on-campus. The on-campus bursary for the Vancouver campus covers 45% of tuition costs for courses taken on-campus. There is no specific limit to the number of on-campus bursaries granted. On-campus bursaries will be issued based on completing the application process in full including completion of the application form, providing a letter of intent to study, and providing two reference letters. On-campus bursaries are available for both full and part-time enrolment.

There is one Working Adults on-campus bursary granted per term/per campus covering 100% of tuition costs for courses taken on-campus. The Working Adults on-campus bursary will be issued based on completing the application process in full including completion of the application form, providing a letter of intent to study, and providing two reference letters. The Bursary Admissions Committee will review applications received in full prior to the application cut-off to select the candidates who will receive the Working Adults on-campus bursary for the Toronto campus and the Vancouver campus. A full time on-campus status must be maintained by the recipient of the Working Adults on-campus bursary, failure to maintain this status will lead to the bursary being discontinued. Special cases should be presented by letter to the student’s advisor.

These bursaries, like all bursaries, cannot be received in conjunction with any other bursaries offered by Yorkville University.
 *Proof of Canadian citizenship or Canadian Permanent Resident status will be required.
